

Terms and Conditions - 7 Bridges Walk 2026 - Raise \$28 in 28 hours to win a Luxury pop-up Picnic.

Entry

1. Instructions on how to enter and prizes form part of these conditions of entry. Entry into the 7 Bridges Walk 2026 Raise \$28 in 28 Hours competition (the **Promotion**) constitutes acceptance of these conditions. 3. The Promoter will take reasonable steps to inform you of any changes to the conduct of the Promotion.
4. The Promotion commences at 8:00am AEDT Wednesday 7 October and finishes at 12pm AEDT Thursday 8 October 2026 (the **Promotion Period**).
5. This Promotion is open to Australian residents who:
 - are aged 18 or over OR are aged under 18 and have permission from a parent or guardian to enter;
 - are registered participant in 7 Bridges Walk 2026 (the **Event**); and
 - raise \$28 or more in donations through their personal online fundraising page for the Event

during the Promotion Period (**Qualifying Participants**).
